Mayor Mike Yoder declared the public hearing open at 5:32 p.m. to set the final tax request. As there was no further public discussion, the Mayor declared the public hearing closed at 5:34 p.m. Brian Hiebner made a motion to set the final tax request rate at .919389. Stan Friesen seconded.
